

2022 Primary Election - McHenry County Offices

County candidates' views on reproductive rights are important. Although these offices do not have direct jurisdiction over abortion policies, support of all reproductive rights including family planning and comprehensive sexuality education is essential at every level. As elected officials these office holders will have the opportunity to exercise political leadership and have an impact on public officials who are responsible for reproductive policies in Illinois.

County boards, school boards, committeemen, and city council members can influence decisions on issues vital to their communities' ability to make rational decisions on public health policies and to meet the reproductive health needs of their citizens. These offices are also often used as first steps in a political career.
