Although these offices do not have direct jurisdiction over abortion policies, it is essential to have support of all reproductive rights including family planning and comprehensive sexuality education at every level. These offices are also often used as first steps in a political career. Some candidates have publicly declared their position on reproductive rights. MCCC does not endorse candidates.

Anti-Choice = Identified and rated by Illinois Right to Life Action and/or Illinois Family Institute
